

**AVAILABLE OPEN CALENDAR  
DATES FOR JUDGE HAGENAU**

(as of May 1, 2012)

Attorneys may set hearings on most matters in accordance with Judge Hagenau's Open Calendar Procedure. The categories of hearings and the dates and times on which such hearings will be held are set out below. **NOTICE OF HEARING MUST BE SERVED AND FILED: (1) For motions to continue the stay under § 362(c)(4), TEN (10) DAYS BEFORE THE HEARING DATE; OR (2) otherwise, for all other motions, AT LEAST FOURTEEN (14) DAYS BEFORE THE HEARING DATE unless a Bankruptcy Rule requires GREATER NOTICE. See, e.g., FED. R. BANKR. P. 2002(a), 2002(b), 3007.**

NOTE: Attorneys are requested to contact **Bonnie Lewis** (404) 215-1193 to obtain a date and time for an **expedited hearing**. Attorneys should be sensitive to the time constraints imposed by the number of motions on a calendar. Motions that take longer than 20 minutes to hear could be reset or heard in part and continued, which could prove inconvenient, if not expensive, to the parties. Therefore, with regard to motions that are likely to be complicated, movant's attorney should consider whether it would be preferable to obtain a specially set hearing for that matter. **Contact Bonnie Lewis or Nicole Thomas at (404) 215-1193** to obtain a date and time for a hearing on a matter that is likely to take significant time.
