<p>Chapter 13 – Pre-Confirmation Plan Modification or Amended Chapter 13 Plan</p> <ul style="list-style-type: none"> • Located under: <ul style="list-style-type: none"> ➤ Bankruptcy Events → Plan 	<p>This <u>new</u> event will be used to file one of the following: 1) a Pre-Confirmation Amendment to an Initial Chapter 13 Plan filed prior to 12/1/2017; or 2) a Pre-Confirmation Plan Modification to an Initial Chapter 13 Plan filed on or after 12/1/2017. Prompts are included to select any embedded motions contained in the plan; or 3) a Statement of Modified Plan (“Modification Statement”) Local Form 21-2017-B with attached Pre-Confirmation Plan Modification. Ensure all prompts are followed.</p>
<p>Chapter 13 – Post-Confirmation Plan Modification/Notice</p> <ul style="list-style-type: none"> • Located under: <ul style="list-style-type: none"> ➤ Bankruptcy Events → Plan 	<p>This <u>updated</u> event prompts filer to answer whether a Certificate of Service is attached.</p>
<p>Certificate of Service</p> <ul style="list-style-type: none"> • Located under: <ul style="list-style-type: none"> ➤ Bankruptcy Events → Other 	<p>This <u>updated</u> event will prompt filer to answer whether a chapter 13 plan is being served. If not, it will prompt filer to enter the name of the document being served.</p>
<p>Certificate of Manner of Service Pursuant to Bankruptcy Rule 7004</p> <ul style="list-style-type: none"> • Located under: <ul style="list-style-type: none"> ➤ Bankruptcy Events → Other 	<p>This <u>new</u> event will be used to file the Certificate of Manner of Service under FRBP 7004 when such service is required.</p>

<p>Notice of Hearing on Confirmation of Modified Plan and Deadlines for Objections</p> <ul style="list-style-type: none"> • Located under: <ul style="list-style-type: none"> ➤ Bankruptcy Events → Notices 	<p>This <u>new</u> event will be used to schedule a confirmation hearing on a Pre-Confirmation Plan Modification. The Local Form 21-2017-C should be used.</p>
<p>Motion to Declare Secured Claim Satisfied and Lien Released</p> <ul style="list-style-type: none"> • Located under: <ul style="list-style-type: none"> ➤ Bankruptcy Events → Motions/Applications 	<p>This <u>new</u> event will be used to request by motion, an order declaring that secured claim(s) have been satisfied and lien has been released under the terms of the confirmed plan. (FRBP 5009)</p>
<p>Objection to Claim (Motion to Disallow Claim)</p> <ul style="list-style-type: none"> • Located under: <ul style="list-style-type: none"> ➤ Bankruptcy Events → Claim Actions 	<p>This <u>updated</u> event will prompt the filer to answer whether the objection includes a request to determine the value of security.</p>
<p>Proof of Claim Attachment 3001(c)(1)(d) – Claim Supplement</p> <ul style="list-style-type: none"> • Located under: <ul style="list-style-type: none"> ➤ Bankruptcy Events → Claim Actions 	<p>This <u>new</u> event will be used to file an attachment to a previously filed proof of claim pursuant to under FRBP 3001(c)(1)(d).</p>
<p>Application for Compensation</p> <ul style="list-style-type: none"> • Located under: <ul style="list-style-type: none"> ➤ Bankruptcy Events → Motions/Applications 	<p>This <u>updated</u> event will contain a link to the new Order Setting Objection Deadline on Application for Compensation, Setting Hearing if Objections are Filed, and Granting Application in the Absence of Filed Objections when the additional compensation sought is less than or equal to the amount set forth in Bankruptcy Rule 2002(a)(6).</p>
