ORDER ALLOWING CLAIM OF ORO-FACIAL CENTER

Oro-Facial Center ("Claimant") timely filed a proof of claim in this matter to which it attached statements of account in the amounts of \$325.75, \$241.27, and \$253.30, for a total of \$821.32. The Claimant did not, however, complete Box 4 of the Proof of Claim form, which calls for the insertion of the total amount of the claim and identification of it as unsecured, secured, or priority. Because the Chapter 13 Trustee is unable to administer a claim that does not set forth an amount, she objected to it. A hearing was scheduled for June 15, 2005.

Although the Claimant's proof of claim is not accurately completed, it provides sufficient documentation from which the Court may make a reasonably definite conclusion that the Claimant claims a valid debt of the total of the three amounts, \$821.32. This conclusion is confirmed by the Debtors' schedule of unsecured debts, which lists the claims in the exact amounts of the three statements.

The Court will, therefore, allow the claim of Oro-Facial Center as an unsecured claim

in the amount of \$821.32.

The Court notes that the Trustee has no objection to allowance of the claim as such. The Court notes, further, that the Trustee properly objected to the inaccurately filed claim because, as filed, it was not capable of being administered.

This Order does not deal with the claim on the merits. Thus, should the Debtor or any other party in interest have a basis on which the claim should be disallowed, an objection may be filed, and the Court will reconsider allowance of the claim in accordance with the provisions of 11 U.S.C. § 502(j).
