**SHOW CAUSE ORDER AND NOTICE OF HEARING**

A Chapter 11 involuntary petition was filed against Atlanta Franchise Holding Group, LLC on March 17, 2010. A summons was issued that same day. The certificate of service attached to the summons certifies that Theresa Seals-Starkes, as counsel for the petition creditors, sent a copy of the summons and involuntary petition by first class U.S. mail to: Atlanta Franchise Holding Group, LLC, 265 Ponce de Leon Ave., Atlanta, GA 30308. No response has been made by Atlanta Franchise Holding Group, LLC.

Rule 1010 of the Federal Rules of Bankruptcy Procedure governs service of involuntary petitions and summons. Rule 1010 requires that service of the petition and summons be made in the manner provided by Rule 7004(a) or (b). FED. R. BANKR. P. 1010(a). Under Rule 7004(b), service by first class mail on a domestic corporation requires service to be made “to the attention of an officer, a managing or general agent, or to any other agent authorized by appointment or by law to receive service of process.” FED. R. BANKR. P. 7004(b)(3). It appears to the Court that service on Atlanta Franchise Holding Group, LLC does not comply with Rule 7004(a) or (b). The Court, therefore, can not enter an order for relief in this case as directed by Rule 1013(b). Accordingly, it is

**ORDERED** and **NOTICE IS HEREBY GIVEN** that Theresa Seals-Starkes appear before this Court in Courtroom 1201, United States Courthouse, Richard B. Russell Federal Building, 75 Spring Street, Atlanta, Georgia, on **April 29, 2010**, at **10:30 a.m.** and **show cause** why this case should not be dismissed.

The Clerk is directed to serve a copy of this Order upon the parties on the attached distribution list.
