ORDER APPROVING SPECIAL COUNSEL, SUBJECT TO OBJECTION (FLAT FEE)

- 1. Pursuant to 11 U.S.C. § 327(e) and FED.R.BANKR.P. 2014, the employment of Special Counsel to represent Debtor[s] and the estate with respect to the Matter on the basis set forth in the Application is hereby approved.
- 2. Any compromise or settlement of claims relating to the Matter is subject to approval of this Court after notice to creditors and an opportunity to be heard with regard thereto. FED.R.BANKR.P. 9019(a) & 2002(a)(3). Therefore, none of Debtor[s], Counsel for Debtor[s], or Special Counsel is authorized to settle, compromise, or release any claims without approval of this Court. If a compromise is reached, Special Counsel or Counsel for Debtor[s] shall file an application to approve same and shall provide notice of the proposed compromise and settlement and notice of a hearing, if required, to the Chapter [x] Trustee, the Debtor[s], and mailing matrix in this case.
- 3. The flat fee provided for in the Application is approved, subject to objection or as otherwise provided herein.
- 4. Any objection to this Order shall be served on the United States Trustee, the Special Counsel, the Chapter [x] Trustee, and counsel for Debtor[s]. If an objection is timely filed, counsel for Debtor[s] shall schedule a hearing on the Application and such objection pursuant to the Court's Open Calendar Procedures, and shall provide notice of such hearing to the United States Trustee, the Chapter [x] Trustee, the Special Counsel, and the objecting party.

Counsel for Debtor[s] is directed to serve a copy of this Order upon the United States Trustee, the Chapter [x] Trustee, Special Counsel, and all parties on the mailing matrix in this case, and to file with the Court a Certificate of Service indicating such service, within three (3) business days of the entry of this Order.
