Motions that take longer than 10 minutes may not be heard to conclusion but will be reset by the Court to the next available calendar. **Contact the Courtroom Deputy at 678-423-3086** to obtain a date and time for hearing a motion for relief from the automatic stay that is likely to take significant time and on emergency matters.

**PLEASE NOTE: Motions for relief from stay must be filed and served at least two (2) weeks prior to the hearing date selected. Co-Debtor Motions must be filed and served at least twenty-one (21) days prior to the hearing date selected.**

**EMERGENCY HEARINGS:** Contact the Office for Court approval prior to scheduling an emergency hearing on any matter.
