NOTICE OF HEARING MUST BE SERVED **AND FILED: (1) For motions to continue the stay under § 362(c)(3) or motions to impose the stay under § 362(c)(4), TEN DAYS BEFORE THE HEARING DATE; OR (2) otherwise, for all other motions, AT LEAST FOURTEEN (14) DAYS BEFORE THE HEARING DATE unless a Bankruptcy Rule requires GREATER NOTICE. See, e.g., FED. R. BANKR. P. 2002(a), 2002(b), 3007.**

NOTE: Attorneys are requested to contact Cheryl Goss (404-215-1021) to obtain a date and time for an **expedited hearing** or any matter that is likely to take **more than 20 minutes** to resolve.
