# Statistics for 12-month period ending 9.30.20

- GANB is the 4<sup>th</sup> busiest BK court in the country 21,909 cases filed
  - (down 1 spot)
- California Central 31,042; Illinois Northern 29,940; Florida Middle 22,612
- Highest filings in calendar year 2010 54,564
- Filings per 1,000 population  $-3.11 10^{\text{th}}$  highest in the country
  - (TNWB ranks #1 with 5.80%)
- 7.2% of all filings were pro se  $-22^{nd}$  highest in the country

# FY21 Budget

- Continuing Resolution ends at midnight December 11
- Another CR is likely
- In the event of a partial government shutdown, the federal judiciary maintains operations for at least 2-3 weeks using non-appropriated funds
- GANB will be open for business!

# COVID and the Court

- First public notice was sent 3.9.20 with 12 additional notices posted and sent
- Meetings of creditors were postponed and deadlines extended; MOCs are now being held telephonically
- Most court hearings and trials are still being held telephonically or via WebEx although more in person hearings are being scheduled.

#### Upcoming Changes to Chapter 13 Plan Form and Related General Orders

- Revised plan form effective 12.1.2020
- New or revised and restated general orders will be entered:
  - Requiring Local Chapter 13 Plan Form and Establishing Related Procedures
  - Order with Regard to Fees, Expenses and Costs of Attorneys for Debtors in Chapter 13 Cases
  - Voluntary Notice Procedures to include requests for additional chapter 13 attorney's fees
- Post confirmation procedures changed from 30 to 25 days

# Changes to Chapter 13 Plan Form

- Comparison document will be provided when plan form published
- Remove the word "timely" when referring to POCs
- Change location for disclosure of DSO obligation on page 1
- § 2.3 add "federal" for tax returns and refunds
- Delete details of § 2.6 (a) and (b) will be included in new GO
- Add language about interest rate for secured tax claims

# Changes to Chapter 13 Plan Form

(Continued)

- § 3.3 changes regarding secured claims to be paid in full
- § 3.4 remove and replace lien avoidance calculation box
- § 4.3 add reference to additional attorney's fees
- § 4.4 reorganization of section to clarify whether priority claims are owed and the nature of the claims
- Signature box changed to reflect that if debtor is represented by counsel, they only have to sign the initial plan.

# Next Generation of CM/ECF (NextGen)

- As of November 1, 2020 106 court units are "live" on NextGen
  - 13 Appellate Court
  - 51 District Courts
  - 42 Bankruptcy Courts
  - Another 41 court units have planned "go live" dates, including GANB
    - Planned migration is weekend of August 6-8, 2021
    - GAMB will migrate the same weekend

#### Next Gen Modules

- Central Sign-On is a mandatory module
  - Allows public filers and court users to have one login and password for all NextGen courts
  - Centralized PACER website to register or upgrade account
  - Information and assistance will be provided by GANB
- eSR (Electronic Self-Representation)

# Important Change for GANB

- On January 31, 2021, after more than 50 years of exemplary service to the Court and the bankruptcy system, Judge W. Homer Drake, Jr. leaves the bench. Please save the date: January 22, 2021 @ 2pm for a special virtual celebration to honor Judge Drake!
- On February 1, 2021:
  - Judge Drake's pending Chapter 7 and 11 caseloads will be reassigned to Judge Paul Baisier.
    - New Chapter 7s will be assigned to Judge Baisier
    - New Chapter 11s are already being assigned to Judge Baisier
  - Judge Drake's pending Chapter 13 caseload will be reassigned to Judge Ritchey Craig
    - New Chapter 12s and 13s will be assigned to Judge Ritchey Craig
  - No changes to the 7/13 trustee assignments in the Newnan Division.

#### Federal Rules Changes Effective December 1, 2020

Bankruptcy Rules 2002, 2004, 8012, 8013, 8015, 8021

#### Rule 2002

Notices to Creditors, Equity Security Holders, Administrators in Foreign Proceeding, Persons Against Whom Provisional Relief is Sought, etc.

- Amendments:
  - Requires giving notice of the entry of confirmation order in chapter 13 cases
  - Limit the need to provide notice to creditors that do not file timely proofs of claim in chapter 12 and 13 cases (currently exists for chapter 7 cases)
  - Add a cross-reference in response to the relocation of the provision specifying the deadline for objecting to confirmation of a chapter 13 plan.
  - Impacts Rules 2002(f)(7), 2002(h), and 2002(k).

#### Rule 2004 Examination

- 2004(c) Compelling Attendance and Production of Documents
  - Amended to "Or Electronically Stored Information" to title
  - Refers expressly to the production of electronic information, in addition to the production of documents
  - Conforms to the current provisions of Civil Rule 45, which is made applicable in bankruptcy cases by B.R. 9016.

#### Rule 8012 Corporate Disclosure Statement

- Delete "CORPORATE" from title of the Rule.
- Conforms to recent amendments to F.R.App.P. 26.1 to encompass non-governmental corporations that seek to intervene in an appeal.
- New subdivision(b) requires the disclosure of the names of any debtors in the underlying bankruptcy case that are not revealed by the caption of an appeal; for corporate debtors.
- Subdivision (c), previously referenced as (b), amended to make clear that all disclosure requirements of Rule 8012 must be supplemented when information provided changes.

#### Rule 8013 Motions; Intervention

- (a) Contents of a Motion; Response; Reply
  - (1) Request for Relief amended to delete the reference to "proof of service" to conform with recently amended Rule 8011(d) that eliminated the requirement for proof of service when filing and services are completed using the court's electronic filing system.

#### Rule 8015 Form and Length of Briefs, Form of Appendices and Other Papers

- Amendment to (g) is made to reflect recent amendments to Rule 8011(d) that eliminated requirement of proof of service when filing and service is completed using the court's electronic filing system.
- The word "corporate" is deleted before disclosure statement to reflect a concurrent change in the title of Rule 8012.

#### Rule 8021 Costs

• (d) is amended to delete reference to proof of service which reflects the recent amendment to Rule 8011(d) that eliminated the requirement of proof of service when filing and service are accomplished using the Court's electronic filing system.
