# **BUTTONS ON NEW WEBSITE**

• There are three buttons on the top left side of the home page:

- 1. Case Locator (PACER) links to login page for PACER
- 2. <u>E-Filing (CM/ECF)</u> links to login page for CM/ECF (live/train)
- 3. <u>Fin. Mgt. Cert. (eFinCert)</u> links to page to file the Financial Management Course Certificate electronically
- There are six buttons in the middle of the home page that link to the following pages and information:
- 1. <u>Case Information</u> –links to a page that contains information on how to obtain case information through PACER, MCVCIS and in person at Clerk's Office. It also includes how to obtain copies of documents at the Clerk's Office, online and through National Archives.
- 2. <u>Local Rules & General Orders</u> –links to the Local Rules, General Orders, and Notes Concerning General Orders.
- 3. <u>Opinions</u> –links to the opinions page under the Judges' Information tab.
- 4. <u>Trustee Information</u> –links to a page that contains information and links regarding the U.S. Trustee Program, chapter 13 trustees, and chapter 7 trustees.
- 5. <u>Bench and Bar Committee</u> –links to the page that contains information about the committee and its members.
- 6. <u>The Reaffirmation Project</u> This button links to the page that gives information about The Reaffirmation Project and setting hearings on reaffirmation hearings.
