

#### WHAT IS A 341 MEETING?

# II U.S. Code § 341 - Meetings of creditors and equity security holders

(a) Within a reasonable time after the order for relief in a case under this title, the United States trustee shall convene and preside at a meeting of creditors...



#### PARTIES INVOLVED – UNITED STATES TRUSTEE'S RESPONSIBILITY

- Duty to Convene and Preside (II U.S.C. § 341)
  - Date and place
  - Order of the meeting
  - Election of trustee
  - Special meetings (FRBP 2003)
  - Attendance by media
- Authority to administer oath (II U.S.C. § 343 & FRBP 9012)
- "United States Trustee" includes designees (FRBP 9001)

#### PARTIES INVOLVED – DEBTOR'S APPEARANCE

- Mandatory Appearance (II U.S.C. § 343)
- Apprehension of Debtor (FRBP 2005)
- Dismissal for Failure to Appear (General Order 2-2005)
- Attorney's Failure to Appear (II U.S.C. 329 & FRBP 2017)

### PARTIES INVOLVED – DEBTOR'S DUTIES

- Cooperate with trustee
- Provide tax return seven (7) days prior to meeting
- Provide identification materials
- Provide financial information:
  - Evidence of Current Income (Most Recent Pay Advice)
  - Financial Account Statements (Petition Date); and
  - Documentation of Means Test Expenses

#### PARTIES INVOLVED – WHO CONDUCTS IT?

- Chapter I3s standing trustee or staff attorney
  - Reviews petition and documents
  - Collects payments from debtors and makes distributions to creditors
- Chapter 7s panel trustee
  - Reviews petition and documents
  - Liquidates assets, if applicable

### PARTIES INVOLVED – CALENDAR CALL AND ANNOUNCEMENTS

- Introduction
- No appearance
- Requesting a reset
- Trustee announcements
  - The meeting is recorded
  - Quiet and no driving!
  - Hanging up after call is concluded
  - Joint debtors
  - Other announcements



### PARTIES INVOLVED – VERIFYING IDENTIFICATION ON THE RECORD

Debtor's Counsel is expected to verify the Identification Documents provided to the Trustee are those of the Debtor who has just been sworn in. Debtor's Counsel should be prepared to make the following statements on the record:

- identify the Identification Documents that were personally inspected by the attorney (name of the documents ie: social security card, GA Driver's License, W-2)
- indicate that the Identification Documents appear to be valid documents that identify the debtor; and
- confirm that the information on the Identification Documents matches the name of the debtor and the identification number that appear on the notice of meeting of creditors.



### PARTIES INVOLVED – EXAMINATION QUESTIONS

- How many years have you lived in the State of Georgia?
- Did you meet with an attorney to assist you in filing your Chapter 13 Plan, Schedules and Statements?
- Did you read and sign your Chapter 13 Plan, Petition and Schedules, before they were filed?
- Is everything in your Petition and Schedules true and correct?
- Did you include all of your debts and all of your assets?
- Are you a member of a credit union or do you have any loans with a credit union?
- Are you required to pay or do you received child support or alimony?
  - How much are you required to pay?
  - Do you pay it directly or is it employer deducted?
  - Are you current?
  - Have you made your ongoing payments since filing?

### PARTIES INVOLVED – EXAMINATION QUESTIONS

- Do you contribute to any kind of retirement account?
- Do you have any loans that you are repaying to a retirement account?
- Are you currently suing anyone or do you have any claims?
  - Examples: worker's compensation, personal injury, or any type of lawsuit?
- Are you still employed by xxxx?
- Is the address of your employer xxxx?
- Is your income xxxx?
- Is your spouse's income xxxx?
- Is there any other income in your household other than what we just discussed?
- Are you married/single/dependents in the Household?
- Do you owe a domestic support obligation to anyone else?
- Have you read the bankruptcy information sheet provided by the United States Trustee?

### PARTIES INVOLVED – EXAMINATION QUESTIONS

- Real estate questions:
  - Is the fair market value correct?
  - Do you own the property alone or with others?
  - Have you made your mortgage payment(s) since filing?
  - Do you understand that you have to pay your mortgage directly?
  - Is there a Home Owner's Association and have you paid them?
  - Do you understand that you have to pay your HOA per that agreement/rules?
  - Do you have an interest in any other real estate?
- Have you sold or transferred your interest in any real estate or personal property in the last 2 years?
- Have you filed any other bankruptcy cases during the last 8 years?
- Have you filed your tax returns for the last 4 years?
- Is the copy of the return you provided to the Trustee a true and correct copy of the most recent return that you filed with the IRS?

### PARTIES INVOLVED – REVIEWING CLAIMS AND PLAN IN CHAPTER

- The Trustee will review the filed or anticipated claims
- The Trustee will review the set payments and special provisions in the Chapter I3 Plan

#### PARTIES INVOLVED – CREDITORS ATTENDING A 341

- Ask how debtor wants to treat a secured debt
- Inquire about insurance
- Question how funds were spent
- Address discrepancies

### PARTIES INVOLVED – CHAPTER 7 BUSINESS 341S

- In a Chapter 7, confirm as soon as possible that the debtor has ceased operations
- Understand how books and records are stored (and if stored in a cloud program, get access immediately)
- Ask if there is any D&O or E&O insurance
- Confirm corporate authority to file

#### PARTIES INVOLVED – CHAPTER 13 BUSINESS 341S

- The Chapter 13 Trustee reviews the Statement of Financial Affairs, Petition and Schedules when a case is filed to determine if a separate business packet is needed to hold the 341 Meeting.
- If the business appears complicated with multiple assets, employees, large gross income, or complex expenses the Trustee may also renotice the 341 meeting to a different date and time.

#### Business Packet

- Business questionnaire
- Cash Flow Statements
- Business Bank Statements

#### PREPARING FOR 341S – PREPARING CLIENTS FOR 341S

- Prepare early and often
- 341 preparation call:
  - Review petition information and general process
  - Review how client should handle the call itself
- Getting the client to call in



#### PREPARING FOR 341S – ATTORNEY PREPARATION FOR 341S

- Provide documents to the trustee
- Review the documents, the client's photo id, and proof of social
- Make sure to call into the 341



#### BEST PRACTICES – DEBTOR ATTORNEYS

- DSO Forms
- Personal injury claims listed correctly and proper information gathered
- Getting documents to trustee in appropriate time frame



#### **BEST PRACTICES – DEBTOR ATTORNEYS**

Get documents before filing!



#### **BEST PRACTICES – TRUSTEES**

- Eliminate legalese where possible
- Be on time
- Be prepared (understand the file before the meeting begins)
