

**OPEN CALENDAR DATES**  
Judge James Sacca - **Gainesville Division Cases**  
(as of December 22, 2025)

**BEGINNING FEBRUARY 1, 2026** - The Gainesville calendar call will be virtual/ telephonic via Judge Sacca's Virtual Hearing Room pursuant to the "Gainesville Hybrid Calendar Procedures" posted on the Court's website or in person at the option of the person appearing. Except for the limited categories of hearings provided in the calendar procedures, in person appearances for any matter held ready will be required at either 11 a.m or 1 p.m. as mutually announced by the parties at the calendar call. If parties do not mutually agree to a time, the matter will be heard in-person at 1 p.m., courtroom 103, Gainesville.

Attorneys must schedule a hearing on most matters in accordance with Judge Sacca's Open Calendar Procedure. The categories of hearings and the dates and times on which such hearings will be held are set out below. All hearings are held in **Courtroom 103, U.S. Courthouse, 121 Spring Street, SE, Gainesville, 30501.**

*Select a date far enough in the future to provide adequate notice under the applicable rules and to allow time for submission and entry of an order prior to the hearing date, if noticed pursuant to standing order no. 2016-JRS or general order no. 24-2018 and no objections/responses are filed.*

If there is no available hearing date for stay relief motions that are at least 14 days but less than 31 days after the filing of the motion and a movant is unwilling to consent to continue the stay, the movant's attorney must call Ms. Gillespie to obtain a special date and time for a hearing. Motions under Section 362(c)(3)(B) and (c)(4)(B) must be filed and served at least 10 days before the hearing date.

**Regarding Reaffirmation Agreements:**

NOTICE REGARDING HEARINGS ON REAFFIRMATION AGREEMENTS: The Court will schedule all hearings on reaffirmation agreements on a single day before the same judge, regardless of which judge is assigned to the case. When self-calendaring a hearing on a reaffirmation agreement, use one of the dates on the Reaffirmation Agreement Hearing Dates page and DO NOT use a regular mass calendar date.
