NOTICE CONCERNING AMENDMENTS TO FEDERAL RULES OF BANKRUPTCY PROCEDURE AND BANKRUPTCY FORMS

As announced by the Administrative Office of the United States Courts, the Judicial Conference of the United States has approved amendments to the Federal Rules of Bankruptcy Procedure (“Bankruptcy Rules”) listed in Section I of this Notice and to the Bankruptcy Forms listed in Section II. The amendments will take effect on December 1, 2010.
