

# AVAILABLE OPEN CALENDAR DATES FOR CHIEF JUDGE HAGENAU

(as of September 25, 2020)

Attorneys may set hearings on most matters in accordance with Chief Judge Hagenau's Open Calendar Procedure. The categories of hearings and the dates and times on which such hearings will be held are set out below. **NOTICE OF HEARING MUST BE SERVED AND FILED: (1) For motions to continue the stay under 362(c)(4), TEN (10) DAYS BEFORE THE HEARING DATE; OR (2) otherwise, for all other motions, AT LEAST FOURTEEN (14) DAYS BEFORE THE HEARING DATE unless a Bankruptcy Rule requires GREATER NOTICE. See, e.g., FED. R. BANKR. P. 2002(a), 2002(b), 3007.**

NOTE: Attorneys are requested to contact **CYNTHIA EADON** (404) 215-1193 to obtain a date and time for an **expedited hearing**. Attorneys should be sensitive to the time constraints imposed by the number of motions on a calendar. Motions that take longer than 20 minutes to hear could be reset or heard in part and continued, which could prove inconvenient, if not expensive, to the parties. Therefore, with regard to motions that are likely to be complicated, movant's attorney should consider whether it would be preferable to obtain a specially set hearing for that matter. **Contact Cynthia Eadon or Nicole Williams at (404) 215-1193** to obtain a date and time for a hearing on a matter that is likely to take significant time.

**REAFFIRMATION AGREEMENTS:** The Court will schedule all hearings for Atlanta Division cases on a single day before the same judge, regardless of which judge is assigned to the case. When self-calendar a hearing on a reaffirmation agreement in an Atlanta Division case, please refer to the chambers page of Judge Ellis-Monro for more specific information. **DO NOT USE** Chief Judge Hagenau's regular mass calendar dates for hearings on reaffirmation agreements.
