Overview

The *Pro Se* Assistance Center (PAC) is staffed by volunteer bankruptcy attorneys and law students. The PAC offers free legal guidance through 20-minute consultations to individuals who are representing themselves in the U.S. Bankruptcy Court. Volunteers can provide information about the bankruptcy process and provide limited case-specific advice, but they cannot represent parties in court or file pleadings.

Center volunteers will see clients on a walk-in basis. However, priority is given to those with appointments.
