

# NEW EVENT – Request for Entry of Order Terminating Employer Deduction Order

This is a docket text only event used by Debtor's Counsel or the Chapter 13 Trustee to request an entry of an order terminating employer deduction order in a **converted** or **dismissed** Chapter 13 case. This event can also be used after the plan has been **completed** and the Chapter 13 Trustee files a Notice of Plan Completion.
